Please make sure to review this agreement before signing it. By signing this agreement or activating your account via regular activation or auto activation you accept that:

- *Regular Activation by customer or Auto Activation by IPWorldTV means that customer accepts all the terms and conditions of IPWorldTV Subscription Agreement whether she/he signs this agreement or not.*
- *You will purchase the equipment for receiving and decoding the IPWorldTV internet broadcasting for a price of \$108.00 for Hybrid receiver or \$99.00 for IP Only receiver. By accepting and/or signing this agreement, you will have two promotion options; 1) You will be able to get 100% discount for the equipment price if you accept and/or sign 24-Month subscription agreement or 50% discount if you accept and/or sign 12-Month subscription agreement, 2) You will be able to get discounted subscription prices during the agreement term, 12 Months or 24 Months. No discounts are available on equipment prices for this option.*
- *If you choose promotion Option 1, depending on your initial subscription payment, you may get 1 month free with 3 month subscription payment, 2 months free with 6 month subscription payment or 3 months free with 12 month subscription payment. No subscription downgrade is available after 30 Days of the activation date.*
- *If you select to terminate your subscription agreement before it expires, you should pay the equipment price given you free as promotion and \$150.00 early termination fee. You also hereby authorize IPWorldTV to charge your credit card for the payments.*
- *Your IPWorldTV receiver must be activated within 15 Days after the delivery of the equipment package, otherwise, on the 15<sup>th</sup> day, it will be activated automatically by IPWorldTV and your subscription will be started. Customer will be responsible for all accumulated balances thereon.*
- *You may return the receiver to IPWorldTV within 30 Days after the activation date of the system. When IPWorldTV receives the returned package, you will be refunded after the deductions of \$20.00 restocking fee for receiver and shipping costs.*
- *With this agreement, you accept to pay all the subscription fees in the agreement period with no interruption. There is no cancellation, hold or service cut in the agreement term.*
- *IPWorldTV Receivers are custom manufactured for IPWorldTV programming only. The receiver will work with your paid subscription for IPWorldTV programming only. IPWorldTV is not responsible for and does not guarantee free-to-air channels and their services.*
- *All of IPWorldTV's receivers are covered by the manufacturer's warranty and most manufacturer warranties are for a minimum of one year. Please note that all manufacturer warranties, either expressed or implied, are direct from the manufacturer to the end user. Products that are out-of-warranty are subject to a repair service fee (+ tax for California Residents).*
